Refunds: Doing Life will at its sole discretion refund the client subject to a 10% handling fee.

Warranty: The warranty on any product sold by Doing Life is a Back to Base warranty and will only be valid on return of the defective product to the premises of Doing Life.

We shall be entitled to re-sell such goods either by auction or by private treaty, and the customer shall be passed a credit for all amounts received in excess of the expenses of recovery and resale, and shall be liable for any shortfall.

All quotations/proposals are valid for a period of 1 (one) day of date of quotation/proposal.

The customer shall be deemed to be the person who has signed on the face of the invoice.
